SUBJECT: Approved Fringe Benefit Rate for FY 14 and Revised Interim Fringe Benefit Rate for FY 15

A composite fringe benefit rate (RATE) of 41.99% has been approved by the U.S. Department of Health and Human Services (DHHS) for FY 14 (attached). Based on the approved FY 14 RATE, the interim FY 15 RATE has been revised. Because we are already in the first quarter of FY 15, the revised interim rate is being transmitted to you for your information and records. Until new fringe benefit rates are approved by DHHS, the following revised interim fringe benefit rates for FY 15 will be in effect:
