My name is Cindy Freitas and I'm a Native Hawaiian descended of the native inhabitants of Hawai'i prior to 1778 and born and raised in Hawai'i.

I am also a practitioner who still practice the cultural traditional customary practices that was instill in me by my grandparents at a young age from mauka (MOUNTAIN TO SEA) to makai in many areas.

I Opposed for the following reasons;

1. In question is the land issue. DLNR are only the lessor of the Maunakea Lands there for the UH dosen't have the jurisdiction to do any/ or subcontract to do a CMP plan (see Admission Act).
2. In question is HRS 711/1107 DESECRATION (b) A place of worship or burial, there is nothing in the CMP that mention this HRS.
3. In question is HRS 103D-324 CONTRACT PERFORMANCE AND PAYMENT BONDS, the CMP doesn't mention any of this. My Husband and I were contractors for 16 years in Hawaii registered and we as contractors like all contractors in the STATE OF HAWAII were mandated to follow rule HRS 103D-324 CONTRACT PERFORMANCE AND PAYMENT BONDS.

Therefor I Cindy Freitas reserve my right as a rightful holder of all lands in Hawaii that I will want to do a CONTESTED CASE on this issue.
