

# Clarification of UH Hilo Distance Learning Program Designation and Student Fee Waivers for Academic Year 2016-2017<sup>1</sup>

## UH Hilo Distance Learning Program Designation

A UH Hilo distance learning program is a degree, certificate, or licensure program that:


- is offered entirely through distance learning modalities by a UH Hilo department<sup>2</sup>,
- has an established process for admitting students into the program<sup>3</sup>,
- has received WASC certification as a DL program<sup>4</sup>,
- has been recognized by the Office of the Vice Chancellor for Academic Affairs as a distance learning program<sup>5</sup>, and
- is listed as a distance learning program on the *Distance Learning Programs at UH Hilo* website<sup>6</sup>.

## Distance Learning Student Fee Waivers as of the Academic Year 2016-2017<sup>7</sup>


Students in designated distance learning programs will continue to have the following select students fees waived each semester for the 2016-2017 academic year.

Student Fees <sup>8</sup> Per Semester	Department	Fee
Student Activities	Campus Center	\$15.00, 1-4 credits/\$30.00, 5 or more credits
Student Health	Health Nurse Office	\$7.00
Student Life Center	Student Recreation Center	\$78.00

Students in a distance learning program who wish to access any of the above services must pay the fees as noted prior to use. Fees may be paid at any time during the semester at the full (not prorated) rate.




