PART I APPLICANT DATA

Pursuant to HRS §78-2.7, the State is required to ensure the reputable and responsible character of applicants and employees, which shall include a criminal history record check. To determine a selectee's employment suitability, the Department of Human Resources Development shall conduct an evaluation, which may include reviewing information from the Hawaii Criminal Justice Data Center (HCJDC) and the Judiciary Information Management System (JIMS).

CONVICTION OF A VIOLATION OF LAW

Convictions shall not necessarily bar you from employment. Factors such as age at the time of the offense, date of the offense, seriousness and nature of the violation, and rehabilitation may be taken into account, provided that the conviction record bears a rational relationship to the duties and responsibilities of the position.

If you answered "Yes" to the above question, include the dates, nature and circumstances of the conviction; the sentence imposed and its current status; and any other relevant information you wish to provide.

NOTE: In answering this question, you need **NOT** report the following:

- Arrests not followed by convictions;
- Convictions which were annulled or expunged;
- Offenses for which you were tried as a minor or juvenile;
- Convictions of offenses punishable by fine only; and
(You must report any convictions that **could have** resulted in a jail sentence even if your sentence was only a fine. If you are in doubt, please answer "YES" and explain in the above question.)
- Convictions of misdemeanors, after which a period of ten (10) years since the date the sentence was fulfilled has elapsed, and there has **NOT BEEN** any subsequent arrest or conviction.

You **MUST** report, within the past (10) year period, excluding any periods of incarceration, the following:

- State, out-of-state, federal, military, international and other convictions; and
- Convictions of **FELONY** and **MISDEMEANOR** offenses (including **PETTY MISDEMEANOR, DRIVING UNDER THE INFLUENCE (DUI), CONTEMPT OF COURT**, etc.)
